Chief Justice Hardesty,

In response to your request at the last ADKT 411 hearing, I am providing an updated list of cases assigned to the Washoe County Public Defender's Office.

The statistics cover cases assigned in the calendar years of 2007, 2008, and the first 6 months of 2009. The definition of "case" is the one set out in the National Center for State Courts' *State Court Guide for Statistical Reporting*: all charges involved a single defendant regarding a single incident as a single case.

Justice Pickering inquired as to whether the caseloads identified in the July 1, 2007 Public Defender Survey included conflict cases. They did not. The numbers in the survey covered FY 2006-07. The FY 2006-07 caseloads also distinguished "open" cases and "reopened" cases.

This office included reopened cases, as they are considered a workload measurement in the National Center for State Courts' guide. For this office, the reopened cases can be matters that have been reinstituted after a defendant has failed to appear. Reopened cases also include parole revocation hearings set in the Nevada Department of Corrections.

To be consistent with the first survey, we have also segregated reopened cases in the current list.

For the court's edification, the felony/gross misdemeanor caseload assigned to each attorney also excludes a significant number of misdemeanor cases handled by each trial attorney. We have a dedicated Misdemeanor Division that provides representation in the majority of misdemeanor filed by the District Attorney's Office. In order to maintain vertical representation, misdemeanors that are filed separately, but as part of a felony/gross prosecution, continue as a workload for the felony attorneys.
