Submitted is Union Township Justice Court's (Humboldt County, as part of Sixth Judicial District) response to Nevada Supreme Court's ADK No. 424 ORDER to have equipment in place allowing telephonic and/or audiovisual participation by September 30, 2009 for civil court participation.

On December 1, 2003, Superior Business Communications and A.G. Telephone Systems completed a joint effort to install in the courtroom of Union Township Justice Court a system which provides; an Innkeeper 1 Digital Hybrid System with Sabine adaptive audio FBX10201 feedback exterminator, an advanced ITS Panasonic Speaker Phone System and three ceiling mounted speakers for even sound distribution.

The installed ITS Panasonic Speaker Phone System has the capability to connect with two out of courtroom locations and allow distant participation in all civil matters.

Recently, Honorable Justice Mark Gibbons visited Union Township Justice Court in Winnemucca. Justice Gibbons and I discussed the instillation of a telephonic system which would be supplied by a private service provider who would coordinate all court approved telephonic civil court appearances as ORDERED by ADKT 424 on December 18th, 2008. I agreed with Justice Gibbons to allow a private service provider to install (at no cost to this court) a new telephonic system in the courtroom and I have not been contacted as of this date by a service provider.

I also have contacted A.G. Telephone Systems and requested a quote to improve our current ITS telephonic system by adding the capability to allow for more than two locations to participate in civil matters before this court.

As of December 1, 2003, Union Township Justice Court had telephonic capabilities in the courtroom. I am actively pursuing to improve this court's capabilities for telephonic communications and at the same time lowering the cost of our tax payers.
