Re: ADKT 0435 - Proposed Language for Amendments to Foreclosure Mediation Rule 13

Dear Chief Justice Pickering, Members of the Nevada Supreme Court, and Ms. Brown:

As agreed to in the public comment provided at the November 5, 2020, Public Hearing on ADKT 0435 – Foreclosure Mediation Rule 13, Home Means Nevada, Inc. (HMN) submits the following proposed language to address the issue of portal access/participation by parties that may not be represented and/or utilizing the portal is not feasible. HMN worked with Mr. Peter Aldous, Attorney, Consumer Rights Project, Legal Aid Center of Southern Nevada, Inc., and Ms. Kristin Shuler-Hintz, Esq. - Partner, Managing Attorney, MCarthy-Holthus, LLP, on this language.

The following is the proposed additional language to be added to the proposed amendments to ADKT 0435-Foreclosure Mediation Rule 13.

"The documents shall be exchanged via the state-sponsored portal unless otherwise ordered by the District Court. The District Court may permit documents to be exchanged by means other than the state-sponsored portal if the Homeowner is not represented in the mediation process and/or the Homeowner certifies in the Petition for Foreclosure Mediation Assistance that use of the state-sponsored portal is not feasible. Relief from the utilization of the portal may only be authorized after the Petition is answered for good cause shown."

The attached form, Exhibit B, would be utilized by the Homeowner and submitted to the District Court.

HMN respectfully submits this proposed language to be included in the amendments to ADKT - Foreclosure Rule 13 that the Nevada Supreme Court is considering.
