SCOTT by and through their counsel of record, KEMP, JONES & COULTHARD, hereby move this Court for leave to file a Second Supplement to their Answer to Petition for Writ of Mandamus of Prohibition in light of recent testimony by Gary Tharaldson regarding the fact that, contrary to the briefing in this matter, neither Layne Morrill nor Marty Aronson is representing him in any matter, nor is any other attorney from Morrill and Aronson. See Petitioners' Supplemental Reply in Support of Petition for Writ of Mandamus or Prohibition at 5:3-8, in which Petitioners state that both Morrill and Aronson are representing Petitioners in the Supreme Court proceedings. Given that this sworn testimony directly contradicts the arguments made to this Court by Petitioners, this Court should have the benefit of this new information to fully evaluate this issue.
