- 1. That the Eighth Judicial District court denied my petition for Writ of Habeas Corpus citing Petitioner as failing to provide proof to support his four (4) grounds for relief at his April 6, 2011 hearing.
- 2. That the assertions raised in two (2) of the grounds raised in my petition are true and alleged ineffective assistance of counsel claims that warranted the Eighth Judicial District Council

to conduct an evidenciary hearing in order to provide the proof required by the Court as proof.

- 3. That the allegation of counsel's ineffectiveness related directly to his failure to investigate or ask any questions to assert on petitioner's prior felonies for constitutionally validity prior to advising Petitioner to stipulate/plead guilty to habitual criminal status and that two (2) of his prior convictions were in fact invalid.
