12 **MOTION TO POSTPONE ORAL ARGUMENT FOR 30 DAYS**

13 Respondents, DUKE RENSLOW and TINA RENSLOW (hereinafter
14 "Respondents") respectfully request that oral argument in this matter, currently set
15 before an en banc court for October 2, 2012 at 10:00 a.m. in Las Vegas, Nevada, be
16 postponed for approximately 30 days to the next available date convenient to the
17 court.

18 NRAP 34(a) allows a party to request that an oral argument be postponed and
19 states that the request "must be filed reasonably in advance of the date fixed for
20 hearing." On August 23, 2012, this court entered an order scheduling oral argument
21 in this matter before an en banc court for October 2, 2012 at 10:00 a.m. in Las Vegas,
22 Nevada.


23 Good cause exists to continue this hearing for 30 days. Respondents' counsel
24 has a scheduling conflict on October 2, 2012 in that she has a Settlement Conference
25 scheduled for that day from 9:30 a.m. to 5:00 p.m. in Supreme Court Case Number
26 56268 which was scheduled on August 20, 2012 with her client coming from the

1 Southern United States to attend the settlement conference.. Furthermore, Appellants
2 have requested that Respondents provide a settlement demand in the hopes of settling
3 this matter, which demand will be sent by the end of this week. Due to Respondent's
4 counsel schedule, the settlement demand was not able to be provided sooner as
5 hoped.

6 This motion has been made in good faith and without intent to delay this appeal
7 unnecessarily. Based on the foregoing, good cause exists to postpone the oral
8 argument in this matter for approximately 30 days until the next available date for en
9 banc oral argument.
