13 **ORAL ARGUMENT FOR 30 DAYS**


14 Respondents, DUKE RENSLOW and TINA RENSLOW (hereinafter  
15 "Respondents"), hereby submit their Reply in Support of Motion to Postpone Oral  
16 Argument for 30 Days as follows:

17 The undersigned does not object to having the argument rescheduled for less  
18 than 30 days. However, in addition to the mediation in the matter which created the  
19 conflict with this oral argument on October 2, 2012, the undersigned also has a four-  
20 day Jury Trial scheduled to begin October 8, 2012, which is a number one set in the  
21 Second Judicial District Court. As the undersigned is a solo practitioner, there is no
