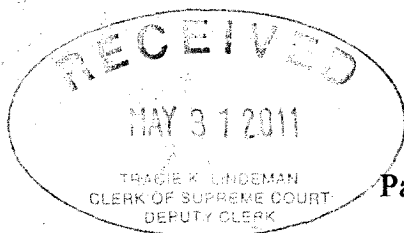
15 **EMERGENCY MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS**
