13 Response to this Court's Order of April 17, 2001.


14 4. That the process of researching and writing

16 previously ordered due date.

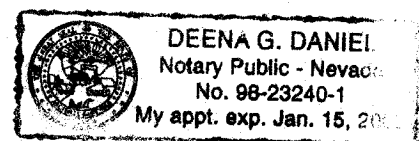
17 5. Accordingly, Appellant moves this Court for an
