

The Order Establishing Pilot Program for the Transitioning into Practice (TIP) Program for newly-admitted attorneys was filed in the Supreme Court on November 16, 2011, in ADKT 0464. The TIP program pairs newly admitted attorneys with experienced attorneys who serve as mentors. To serve, mentors complete an application that is screened by the state bar's TIP Standing Committee.
