Nature of Action. This is a water rights adjudication proceeding. Bentley is in a 10. unique position in that it enjoys the right to divert (but not consume) water from Sheridan Creek above its allocated amount pursuant to a Water Diversion and Use Agreement that was recorded in the Official Records of Douglas County, Nevada, on 27 March 1987. The water is to be diverted through Bentley's ponds and then returned to the creek and ditch system for use by other claimants. Intervenors filed multiple motions to have the lower court override that Diversion Agreement and instead impose a rotation schedule. On 15 April 2011, the lower court granted Intervenors' motion(s) and entered an Order which effectively restrained Bentley's diversion of the amount already adjudicated in its favor in the Final Order of Determination and any diversions under the recorded Diversion Agreement; instead, the lower court entered a temporary order for the Office of the State Engineer to implement a twenty-one (21) day rotation schedule on a temporary basis. As a result, Bentley gets the full flow of water from the North Branch of Sheridan Creek 1.6 days out of the twenty-one (21) day rotation cycle. There is no statutory basis or need for this Order, and it was entered without an evidentiary hearing or a requirement for Intervenors to post a bond. Bentley appeals from this Order as if it were a temporary restraining order.
