
10 **MOTION FOR EXTENSION OF TIME TO FILE OPENING BRIEF**

11 Appellant hereby moves for a 30-day extension of time for filing the opening brief and
12 appendix. The brief is currently due on June 20, 2012. Therefore, appellant seeks an extension
13 until July 20, 2012.

14 This is an appeal from a judgment in the amount of approximately \$6 million, in a
15 personal injury case. There were multiple post-trial motions, and a multi-volume trial transcript.
16 These materials needed to be read, summarized and analyzed for the appeal. Additionally, there
17 were some delays in obtaining the trial transcript.


