DECLARATION OF AUDREY M. CONWAY

- 1. I am an attorney licensed to practice law in the State of Nevada; I am a deputy public defender assigned to handle the appeal of this matter; I am familiar with the procedural history of this case.
- 2. Our office filed the Notice of Appeal in this matter on November 15, 2011. This case is governed by the provisions of NRAP 3C, which requires the Appellant to file a Fast Track Statement 40 days after the filing of the Notice of Appeal.
- 3. I filed a Request for Rough Draft Transcripts on November 15, 2011. The reporter/recorders received the request on November 15, 2011. NRAP Rule 3C required the reporter to produce the rough draft transcript by Monday, December 5, 2011.
- 4. The original intent of NRAP 3C was to allow court reporters twenty days to file all requested transcripts, and allow trial counsel twenty days thereafter to file the fast track statement. In many cases counsel does not receive the transcripts for at least 5-7 days after they are filed.
- 5. As of this morning, January 3, 2012, I had only received 7 of 9 requested transcripts. The transcript(s) of May 16, 2011 and May 25, 2011 were still outstanding. However, the appellate secretary conducted a review of Odyssey and determined that the transcripts were in fact filed. She obtained a copy of said transcripts and the Appendix has been compiled and will be Bates stamped this week. Accordingly, I am requesting an extension of time within which to prepare and file the instant Fast Track Statement.
