1 MEMORANDUM

2 I, NANCY A. BECKER, am the supervising attorney in the above-captioned
3 case. This Court can extend the time to file a Fast Track Response upon
4 demonstration of extreme need or merit. NRAP 3C(h)(2). No previous extensions
5 have been granted to the State. Prior to the filing of this Fast Track Statement,
6 Appellant received an extension of time from the Court.

7 As good cause for the extension, the State cites the number of issues set
8 forth, the size of the record and the Nevada State Bar examination. This case
9 consists of a three (3) volume appendix—consisting of 494 pages. The seventeen
10 (17) page Fast Track Statement raises approximately four (4) issues and three (3)
11 sub-issues. In addition, the law clerk to whom the Fast Track Response was
12 assigned sat for the Nevada Bar exam during the week of February 27, 2012. He
13 received the assignment only days before the Bar Exam.

14 Due to the above-described circumstances, Respondent respectfully requests
15 this Court's permission for an extension of time of 20 days to file its Fast Track
16 Response; making the Response due to be filed on or before Wednesday, March
17 28, 2012. This motion is made in good faith and not for purposes of undue delay.
