UNOPPOSED MOTION FOR EXTENSION

(Second Extension Requested)

Pursuant to NRAP 31(b)(3), Rapid Cash moves for an extension of time of 30 days in which to file its opening brief and appendix, or until January 4, 2013. The brief is currently due to be filed on December 5, 2012. This is the second request for an extension on this brief under the current briefing schedule. (The deadline was previously extended by stipulation of the parties pursuant to NRAP 31(b)(2).) ***Respondents' counsel have represented that they do not oppose this motion.*** (Appellants appreciate their courtesy.)

Although the opening brief is substantially completed, more time is needed to finish it. Counsel for Rapid Cash was involved in a trial that went far longer than was expected, which consumed a considerable amount of time. In addition, Rapid Cash's counsel conducted an oral argument before this Court which

involved issues of first impression and required substantial preparation. The time remaining was unfortunately consumed by a confluence of family issues affecting the various attorneys working on the brief.

Rapid Cash therefore respectfully requests an extension of 30 days in which to file its opening brief and appendix.
