**FIRST MOTION TO EXTEND TIME TO FILE**

## MEMORANDUM OF POINTS AND AUTHORITIES

This Motion is authorized pursuant to Rule 3C(h)(2) of the Nevada Rules of Appellate Procedure.

This is an appeal from the district court's order denying appellant's Petition for Writ of Habeas Corpus (Post-Conviction), subject to the provisions of Nevada Rules of Appellate Procedure 3C. Appellant's petition was denied by the district court, on January 27, 2012. Appellant filed his Notice of Appeal on February 7, 2012. The Notice of Entry of Decision and Order was filed February 16, 2012. This Court ordered Appellant's Fast Track Statement and Appendix due March 19, 2012. This is the first request for an extension of time to file the Fast Track Statement and Appendix. The

undersigned counsel respectfully requests an additional thirty (30) days to file.

To date, undersigned counsel has not received the Rough Draft Transcript of the Evidentiary Hearing on Mr. Brown's petition. Contact with Court Reporter Maureen Schorn indicates the transcript will be provided to the undersigned this week. Thus, undersigned counsel is requesting a thirty (30) day extension for which to prepare Appellant's Fast Track Statement and Appendix.
