**MOTION TO EXTEND TIME TO FILE**

The district court's decision was made on January 27, 2012. Mr. Brown's Notice of Appeal was filed on February 7, 2012. Appellant's Fast Track Statement was filed on April 18, 2012. Appellee's Fast Track Response was filed on April 30, 2012.

Undersigned counsel has been working on a pretrial petition for writ of habeas corpus in a capital murder case, State v. Clark, C280364. The petition is due May 15, 2012. Therefore, undersigned counsel needs additional time to review and reply to the State's Fast Track Response in the instant case.

This is the first request for an extension of time to file the Reply to Fast Track Response. The undersigned counsel respectfully requests an additional seven (7) days to file.
