years now. I've been a forensic pathology eight years now.

Q Have you ever qualified as an expert in the courts of Nevada as an expert in the area of forensic pathology?

A Yes.

MR. LALLI: Your Honor, at this point I would ask that Dr. Kubiczek be allowed to render his opinions in the area of forensic pathology.

MR. PIKE: We have no objection to that, Your Honor. We also stipulate as to the identity of the individuals on whom he performed the autopsies on in this case.

MR. LALLI: We'll accept that stipulation.

Q Can you briefly explain to the jury what is the objective of forensic pathology? What do you -- what do you try to do?

A Okay. First, I would like to explain the meaning of pathology. Forensic pathology is a part -- it's a subspecialty of pathology. Pathology is the study of diseases in general. Now, forensic pathology is a study of diseases and injuries and application of this knowledge at the court of law.

So forensic pathology -- a forensic pathologist, through his or her studies, including postmortem examinations,

review of medical charts, reviewing of investigative reports, review of toxicology results tries to establish cause and manner of death.

Q Okay. So when you say your objective is to determine the cause of death and the manner of death?

A Yes.

Q What do you mean by the cause of death?

A Cause of death is basically illness or injury or some pathology change that causes death, demise. The manner of death, this is how a person dies. And examples of manner of death are as follows. There's natural death, for example due to cardiovascular disease. There is accidental death, for example during motor vehicle collisions. There is suicidal death where the manner of death is suicide, for example somebody shoots themselves through the head. Then you have homicides.

THE MARSHAL: Excuse me. Okay. Sorry.

THE COURT: Go ahead, Doctor.

THE WITNESS: Then you have homicide. We use very simple terminology. Definition of homicide in forensic pathology, it is basically death caused by action of others or actions of others. We are not preoccupied with intent in those cases.

24 BY MR. LALLI:

Q So will you call a homicide death when somebody

brings about the death of another person?

A Yes.

Q Okay. You indicated that one of the things you use to do this is a postmortem examination; is that correct?

A Yes.

Q Is that another term for autopsy?

A Well, there are a few types of postmortem examination. Autopsy is one of those types, one of the postmortem examinations.

Q Briefly explain for us what an autopsy is.

A Autopsy is the ultimate physical examination. It consists of external examination where we look at the surface of the body to establish if there are any illnesses present on the surface of the body or in -- we are also looking for evidence of injuries present on the surface of the body. Then we perform -- we open the body cavities and we perform postmortem examination. And, again, we are looking for evidence of illnesses and we are looking for evidence of injuries.

Then we send out some samples of tissues or fluids for toxicological studies. And then after reviewing the investigative reports, reviewing the findings during the autopsy, and reviewing the toxicology testing, then we establish what is the cause and manner of death.

- Q Doctor, first I'd like to talk to you about tattoos.
- 5 Did you observe any tattoos on Victoria's body?
- 6 A Yes.
- 7 Q Can you describe them for us?
- 8 A There were three tattoos present on -- present on 9 the upper back.
- 10 Q Okay. I'm going to display State's Exhibit 208.
- 11 Are we seeing the tattoos in this photograph?
- 12 A Yes.
- 13 Q Now, before I get to the tattoos, does there appear
- 14 to be a placard in the photograph?
- 15 A Yes.
- 16 Q What is the placard?
- A That's a label from the coroner's office. Basically
- 18 it states that this was the year 2006, that's what 06 means,
- 19 2006. Dash 4156, number 4156 indicates that's the case number

- 21 Q So the placard identifies this photo with this

- Q All right. Describe the photograph or the tattoos

A The photograph represents the upper back. And we can see three tattoos. This is decedent's left side. This is decedent's right side. And this is the posterior aspect of the neck. Posterior means back aspect of the neck. So on the left side of the back, upper back, you have the Maltese cross with flames, then you have a tattoo representing the name Nicolin, and then you have on the right side of the upper back you have a black, blue, and orange tattoo representing a butterfly.

Q Okay. Now, I want to ask you if you observed any evidence of injury on Victoria's head and neck.

A Yes.

Q You talked about blunt force injury and sharp force injury. Let's talk about blunt force injury first. What is that?

A Blunt force injuries are injuries caused by blunt objects like a baseball bat, a pipe. Sharp force injuries are the injuries caused by sharp objects like a knife. Now, blunt force injuries mostly consist of abrasions, abrasions, those are scrapes of the skin, contusions, bruising, and lacerations. Lacerations are tearing of the surface of the skin with underlying soft tissue.

Lacerations at first glance may look like cuts, but when we look closer you will notice that lacerations have irregular edges. In case of cuts, the wounds have very nice

straight edges. And also inside the laceration you may see 1 2 what is called tissue bridging, it's little strands of tissue 3 connecting both sides of the wound, and this is in case of 4 laceration.

- 0 Now, when you observed Victoria's body, I want to just focus on her head for a moment, is this the condition of her head, so in other words hair attached?
 - Α Yes.

- Did you remove her hair for any purpose?
- After we took photographs of the head, we removed 10 Α 11 the hair.
- And were you able to observe injury, blunt force 12 Q injury on her head? 13
- 14 Α Yes.
- 15 Okay. I'm going to show you State's Exhibit 208.
- Can you explain for us what we're seeing here? 16
- 17 This photograph represents the right back aspect of 18 the head and neck. Now --
- 0 Can you describe the injury contained in the 20 photograph?
 - Α So you can see the right side here including right ear. Then we have multiple lacerations, again, tearing of the tissue of -- tearing of the skin with underlying soft tissue. So we have lacerations here, which is right parietal right skull. Here is near the apex of the skull. This is irregular

laceration of the left parietal scalp.

This is laceration of the occipital scalp. This is, again, laceration of the right aspect of the occipital scalp. And this is laceration of the right aspect of the neck. Then here you can see there are actually four abrasions which are parallel. Then, again, here there's another laceration of the left aspect of the occipital scalp.

That's many injuries of the head and neck. A lot of them they overlap, so you may see in very -- very closed -- close vicinity presence laceration, abrasion, and contusion. Therefore, in my report I divided all those injuries or groups of injuries into nine different -- 19 different points, 19 different groups or injuries just so it's easier to represent them in my report.

Q So when you say there's 19 different groups or areas of injury, and you -- you've identified some of those for us, does each one of those represent a separate infliction of either blunt force or sharp force injury?

A Well, I cannot say that because, again, those injuries overlap. And some of them they may be a single blow to the back of the skull. However, there are areas, again, where the injuries overlap, so there may be actually more than one blow to that particular area.

Q Okay. Now, I want to show you the other side of her head. Can you please describe the -- can you describe the

injuries we're seeing there?

A This photograph represents the left aspect of decedent's head and neck. And you can see here, again, lacerations of the left parietal scalp. Here is a laceration of the left aspect of the occipital scalp. You can see that this laceration penetrates into the skull.

Again, here is another laceration. Here are two parallel abrasions present on the left posterior aspect of the neck, and here -- sorry. I pushed the wrong -- sorry. Here we have the sharp force injuries present on the left aspect of the neck.

- Q Okay. Can you explain for us what a pattern injury is?
- A A pattern injury is a type of injury that has features that corresponds to the -- either the shape of the object or the surface that cause -- that caused it.
- Q Did you observe any evidence of pattern injury on Victoria's head?
- A My opinion those four abrasions that are present on -- on the right lower aspect of the neck maybe called patterned injury.
 - Q What about the injury to her head?
- A Most of the time those are irregular or linear lacerations. They don't have a particular pattern. There is a group of those two abrasions that are parallel that involve

the left lateral aspect of the neck. This is very consistent with injuries caused by long and round or long oblong object like a pipe, a rod.

Q Okay. Let's -- we'll go to that injury. I'm going to show you State's Exhibit Number 211. When you talk about parallel pattern injury, what are you talking about?

A Again, this is an up close photo of the posterior aspect of the neck.

Q So the back of her neck?

A That's correct. So here we can see the -- two parallel abrasions present on her neck, on back of her neck. And then here you can see that group of those four abrasions on the right back aspect of the neck.

Q So you talk about how something linear such as a rod could have caused that injury?

A Yes.

Q And how would -- how would a rod or some instrument leave that sort of an injury there?

A You know, basically there's -- this is the site of impact --

Q Okay.

A -- of the rod or pipe.

Q Okay.

MR. LALLI: May I approach the witness?

25 THE COURT: Yes.

1 BY MR. LALLI:

Q Doctor, I'm going to show you State's proposed Exhibit Number 190.

A Yes.

Q Now, with respect to -- going back to her actual head. As part of the autopsy procedure, is the skin of the head pulled back and removed?

A Yes. The scalp is cut and deflected so then we can cut the skull and open it to view inside of cranium and, again, check for the injuries inside there, check for illnesses.

Q When you did that in this case were you able to match up injury on the scalp with the external injuries that were seen on Victoria's head?

A Yes.

Q Okay. I'm going to show you State's Exhibit Number 212. Can you explain for the jury what we're seeing there?

- A Basically this is upper part of the skull.
- Q Can you show us --

- A After we removed the --
- Q -- on your head --

A —— after we remove the scalp, after we deflect the scalp, we cut the skull around using a Stryker saw. It's a special saw to cut the bone. And then we remove the upper part of the skull. And this photograph shows the upper part of the skull. This is the front and this is the back of the skull. So we removed the upper part of the skull and it's basically sitting upside down right now. And we can see here two depressed fractures of the skull.

Basically this fragment of the bone fell out from this area in the moment when we were removing this part of the skull, so it's our artifact, artifact of the autopsy. Then we can see other fractures of the -- this part of the skull. We can see very thin linear fractures running through the left and right parietal bones, left and right bones that constitute the skull, the parietal bones.

- Q Now, you described the -- the shapes of the skull fractures as oval, depressed fractures.
 - A Yes.

- Q Can you describe that for us?
- A The hyoid bone was fractured. To be more precise, the left ramus or left part of the hyoid bone was fractured. There was also a hemorrhage surrounding that area indicating that this injury happened in perimortem time.
- Q What is perimortem time?
- 15 A It's the time around death.
 - Q And what -- what causes the hyroid bone to be fractured?
 - A It's basically seen very often in strangulation, particularly manual strangulation. But also this fracture may be caused by other reasons like blunt force injury of this particular area of the neck.
 - Q Blunt force injury meaning something striking that area of the neck?
- 24 A Yes.
- Q Which causes the hyoid bone to fracture?

A Yes.

Q Okay. Did you -- you talked a little bit about sharp force injuries. Did you see or observe sharp force injuries on Victoria's body?

A Yes.

Q I'm going to zoom into State's Exhibit 209. Are we seeing sharp force injuries here?

A No, this is actually right aspect of the decedent's head.

Q Here we are. Let me zoom back out. For the record we're looking at State's Exhibit 210.

A Those are actually, again, those abrasions we were talking about, and this is a laceration, actually, in this area. The injuries, the sharp force injuries, to be precise, stab wounds were present on decedent's left side of the head and neck. So it would be the opposite side from --

Q Okay.

A -- this photograph.

Q Let me bring these up to you so you can --

MR. LALLI: May I approach the witness, Your Honor?

THE COURT: Yes.

22 BY MR. LALLI:

Q Okay. State's Exhibit Number 209.

A Here's left -- this photograph shows the left side of the decedent's head and neck and the stab wounds present

are here, the three stab wounds. And this was -- one of them was behind the left ear.

Q Okay. Did you observe evidence of injury on the decedent's chest and abdomen?

A Yes.

Q Okay. I'm going to show you State's Exhibit Number 202. What are we seeing there?

A Basically there was a contusion of the left aspect of the abdomen. Those changes we can see here, most of those are post -- those are decomposition changes. This is, of course, purple, green discoloration of the skin. There's a skin blistering and slippage, and then you have -- you have this web-like pattern on the decedent's body. This is called marbling. It's basically this is created by decomposing blood present in decedent's vessels.

Q Okay. What are we seeing in State's Exhibit Number 203?

A Those are basically the lower part of the body.

And, again, you can see the decomposition changes that I mentioned. And then there are -- there are abrasions of decedent's left knee, and abrasion of the anterior aspect of right thigh.

Q And do you consider those abrasions to be blunt -- is that blunt force trauma?

A Yes.

Q Okay. Now, as part of the examination, do you complete a toxicology analysis?

A Yes, we draw fluids, available fluids and tissues for toxicology studies. In this case we obtained decomposition fluid that was present in decedent's body cavities, and then we obtained the liver tissue and we sent those specimens for toxicology studies.

- Q And what were the results of the toxicology studies?
- A Decomposition fluid was positive for cocaine and benzoylecgonine. Benzoylecgonine is a metabolite of cocaine. And then it was also positive for a small amount of alcohol.
- Q When a body decomposes, is it common to see some levels of ethanol or alcohol in the blood or in the bodily fluids?
- 15 A Yes.

Q Is the amount of ethanol or alcohol that you -- that was detected in this case consistent with what we would find as part of the decomposition process?

A I mean, in this case there was 0.1 gram percent of alcohol. And -- and this was -- this alcohol was present in the decomposition fluid, so this could be either from consumption of alcohol or from the fermentation that took place in -- as a postmortem change or both. At this point I cannot -- I mean, I cannot say if this alcohol was only due to decomposition or only due to consumption. It may be actually

both, but I don't know that exactly.

Q Cocaine is not part of the decomposition process. That's something that somebody would ingest.

A Yes.

1.5

Q Okay. Based upon the degree of the decomposition that you observed, do you have any opinion as to an approximate time frame of when the injuries occurred?

A Unlike in TV and CSI shows, forensic pathology really very often we don't know exact date or time of death. We can only use general terms. In this case I can only say that the death occurred -- occurred between the -- when the scene was found and time when she was last seen alive. And to be a little bit more precise, the death occurred within days prior to her being found.

Q Okay. So -- so days is really the time frame that you can give us?

A Yes.

Q With respect to the injuries that she suffered on her body, is it your opinion that they -- all of those injuries occurred at approximately the same time?

A Yes. They happened around -- it was a perimortem time interval.

Q Okay. Did you come to an opinion as to the cause of death of Victoria Magee?

A Yes.

O What was that?

A It was blunt and sharp force injuries due to assault.

Q And how does -- how does one actually die as a result of receiving those blunt force and sharp force injuries?

A At least three factors come together causing death. One, destruction of the organs or tissues, like in this case there was intracranial hemorrhage. There was injury to the brain. Then, two, loss of blood. Obviously all those injuries cause loss of blood. And, three, the -- it's a shock that arises from those injuries. So three of those elements come together and cause death.

Q And about how long -- can you estimate how long it would take somebody to die from the time those injuries were inflicted until life actually left them?

A I can only say minutes.

Q Do you have an opinion as to the manner of death?

A Yes.

Q What is that?

21 A Homicide.

Q So death brought about by the actions of another person?

24 A Yes.

Q Okay. Let's switch gears and talk about the autopsy

- Q Okay. I'm going to show you what we've now marked as State's Exhibit 213. Can you describe what we're seeing there?

A This photograph represents the left aspect of the decedent's face, head, and left aspect of the neck. Here we see the label with the case number at the base. And, you know, this photograph is a type of ID photo we take after cleaning the face. So this photograph was taken after cleaning the face.

And here we can see the massive injuries involving the face. Those darker areas, those are contusions, bruising. So we have multiple contusions involving left aspect of the face, medial aspect of the face. There is bilateral periocular ecchymosis, meaning that -- there's other common term for that is raccoon eyes basically. And this finding is very often associated with fractures of either the bones of the face or the base of the skull.

Then we can see also multiple lacerations, tearing of the skin and underlying tissues, lacerations and contusions and abrasions. Again, there are many blunt force injuries involving the head and neck. They, again, overlap, so in my report I represented those injuries or groups of injuries as seven separate points, but just for the ease of presentation of the findings.

And here you can see a sharp force injury, which is in this case incised wound. It means cut. So the cut runs across the -- the neck, anterior aspect of -- front aspect of the neck. The wound was six inches long and about one inch

deep.

Q And with respect to that wound, what sort of damage to the neck would that sort of injury inflict?

A One inch deep wound would go through soft tissues of the neck, including important vessels like carotid arteries, jugular veins, and other smaller vessels. This would cause significant loss of blood.

Q If untreated, would the sharp force injury to Charlotte's throat, would that result in her death?

A Yes.

Q If untreated, the blunt force trauma to her face, would that in and of itself be sufficient to result in death?

A Yes.

Q As part of the autopsy, did you also pull back the skin of her head?

A Yes.

Q Did you observe injuries to the bones of her face?

A Yes.

Q Can you describe that briefly?

A There were multiple fractures of the left aspect of the lower jaw called mandible, left aspect of the mandible was fractured. There were multiple fractures of her teeth on the left side. There were fractures of the maxilla. Maxilla, it's a bone that constitutes the upper jaw.

There was -- there was fracture of the left

zygomatic bone, which constitutes the left temporal area. 1 2 There were fractures, multiple fractures of bones constituting the left eye orbit, so actually the left eye orbit was -- had 3 multiple fractures. There were multiple fractures of 4 5 decedent's nose.

- Α Yes.

- Can you describe that for us? Q
- There was a fracture of the cervical vertebral Α column at the C3 level. That's the mid aspect of the neck. 12 This fracture was accompanied by the hemorrhage within soft tissues. And there was also compression of spinal cord in 13 this area. 14
- 15 0 So you indicated kind of the front of your neck area when you were talking about the C3 that was fractured. 16
- I mean, I show it this way the level of C3. 17 Yes. 18 But actually the vertebral column is in the back of our neck.

 - 0 You indicated that there was hemorrhage around that injury?

- A Again, presence of the hemorrhage around this fracture indicates that this happened around time of death.
- Q Okay. And how -- how would you expect that area of the vertebral -- vertebral column to be fractured?
- A This may happen because of hyperextension, meaning overextension of the neck. You may see this when very significant force acts on the front of the face and causes the overextension. You may see this, for example, in motor vehicle collisions.
- Q So if -- if a person were just standing upright and a tremendous amount of blunt force trauma hit that person in the head and it caused their neck to go back, would you expect to see a fracture of the C3 area of the vertebral column?
- A Yes.

- Q Okay. I'm going to show you State's Exhibit Number 214. I'm going to try to put the light on again without shutting the whole thing down. What -- what are we seeing here?
- A That's the photograph of the decedent's face, neck, and front aspect of the -- her body, including upper extremities.
 - Q Okay. I'm going to turn the top lights off.

Q I'm going to show you State's Exhibit Number 218. What are we seeing here?

A Here is a photograph of decedent's buttock and back aspects of both thighs and low legs. And you can see here the extensive contusions of the right and left buttock, predominantly on the right side. Then you can see also the changes like contusions of the right thigh. Sorry.

- Q When you go to perform the autopsy you don't actually see the body in an unwashed condition, do you?
- A Yes, I do.
- Q Okay. Do you wash the body and prepare it for the autopsy or is that done by your assistants?
- A It's done by my assistants.
- Q In this case did you make any notes -- or do you recall whether or not there were any rocks, or dirt, or sand that was on the legs or knees or either of these two bodies?
- A I note there was dirt present on the -- on the bodies, because we had to clean the bodies before -- we always take photograph -- I mean, the assistants take photographs

before the body is cleaned with all the dirt and little particles on the body surface. And after the body is cleaned.

- Q You didn't note that there were any abrasions or any cuts or tears or any injuries on the bottom of the feet, did you?
 - A No, because of the decomposition changes, some of the findings may be obstructed by the decomposition changes.
- Q Okay. But after you washed it and you did examine that portion of the body --

 - Q -- and it's not noted in your report that there was any abrasions or cuts there?

Q So in taking that into account were you provided with a copy of the weather report for the week, or weeks prior to the time that you received these bodies to perform the autopsy?

A I don't recall that, no.

Q When you say that -- when you give an opinion that you can only give within days as far as the time of death, is that one or two days, or two or three, or three or four?

What's -- can you give me kind of a parameter on either side?

A I can only say days, meaning less than a week.

Q So from the time that the bodies were brought in, it was less than a week from the time of their death?

A Yes.

Q And because of the nature of the decomposition, as well as the limitations that we have forensically at this point in time, you can't say which of the two individuals died first?

A No, I cannot say that.

Q When you go through and perform an autopsy, I note that you weigh organs as they are removed. Do you look at them to determine if there's any diseases that are in -- that

are affecting either of the two people that you performed these autopsies on, did you note whether there was any illnesses or medical conditions on either one of the two girls?

- A No, I didn't notice that.
- 6 Q Okay. So --
 - A I noticed the external and internal injuries. Both ladies were both pretty young and well developed.
 - Q Okay. They appeared to, in all other aspects, to -well to not be suffering from any illness or disease that you
 could determine?

not forensic toxicologist. And, you know, interpretation of the amounts -- those amounts really in postmortem environment belongs to the forensic toxicologist.

Q In determining the date and time of a death you'll often look to wounds or injuries to try and date those wounds or injuries, don't you?

A Well, dating injuries, especially blunt force injuries, including lacerations, abrasions, contusions, it's very complicated. And actually, many experts in forensic pathology do not agree on how to date those injuries.

So very often when it comes for some -- to contusions, they are dated recent or remote. There are some people attempting dating lacerations, for example. However, again, the experts do no agree on how to do that really. And lots of those dating procedures are very subjective.

So, I encountered in literature just using the terminology, if it's a person perimortem, or a recent -- right before death, or it's remote, meaning, there's some evidence of healing like scabs, or some other changes.

So, again, unfortunately we cannot really date especially blunt force injuries. We can -- we had -- we have to use just general terms, again.

Q General terms. And specifically in this case, the -- all of the injuries were what you would call perimortem, at or near the time of death?

A Yes.

Q And let me ask you a little bit about blunt force trauma. And there were a number of injuries that you indicated that were blunt force trauma to the head, both of these ladies; is that correct?

A Yes.

Q And blunt force trauma is similar to getting punched by a boxer or getting hit with a bat. I think you used that as an example?

A Yes.

Q When someone is struck or hit in -- against the head the mechanism often causes the brain to either force itself back against the inside of the skull or otherwise causes it to lose consciousness?

A There may be a loss of consciousness but it's not it's not the rule. It may or may not be.

Q Your forensic capabilities are limited. You cannot tell whether or not there was a loss of consciousness upon a first strike, or whether -- whether it was ultimately the individuals just passed away without ever losing consciousness?

A Yes, I don't know that.

Q There -- also limitations to forensic science often prohibits you or does not enable you to say who, in the case of a homicide, may have caused the death of another person?

A Yes.

Q And you can't tell how many people were involved in a homicide, can you?

A No.

Q You -- in making a determination in relationship to this you also can't determine whether or not the person that was committing the homicide, death at the hands of another, whether they were right-handed or left-handed?

A Yes. I cannot say that.

Q Cannot for that. And you can in examining a body, I guess, determine whether or not there is any blood left in that body or whether or not the blood has dissipated from the body. Can you do that?

A Well, definitely there was some blood left because — in the body because they was decomposing and showing up as a marbling on the skin surface. So there was some blood. But there was not enough for us to collect it and test, for example, for the drugs.

So instead of using blood we couldn't obtain in reasonable amounts we tested decomposition fluid and liver tissue.

Q In fact, when there is a body that oft times a body may be found in a decomposing position there's a lividity or blood that flows down to the lower parts of the body. For instance, if I was to pass away from a heart attack and fall

to the floor here, after a couple of days the blood in my body would start to seep down to the lower parts of my body, wouldn't it?

A Yes.

Q And you didn't see that in these two bodies that you performed the autopsies on?

A Well, I saw the other decomposition changes. But I think -- may I check this?

Q Sure. Absolutely. Yeah, what you're referring to is your autopsy report --

A Yes.

Q -- to refresh your recollection? And that's been provided to the State, as well as a copy to the defense.

A Yes, actually I did find this dark discoloration of the skin over the posterior surfaces of the body. So that may indicate the presence of the lividity. But it's -- it may not be as well visualized like in bodies that have been dead for 12 hours.

Lividity appears even in live person when the cardiovascular system starts to fail, right before their death, and it's called cemetery rose [phonetic]. If anyone sees that, now we can know that it's indicating a cardiovascular failure and it's near death.

Over time, after death, lividity gets fixed and then becomes a part of the decomposition changes. So sometimes it

becomes much, much harder to see that.

- Q And in -- also some restrictions you have, at least in the aspects of these bodies that were presented to you, you cannot tell, for instance, in Charlotte's -- the autopsy of Charlotte whether or not the fracture was pre or postmortem. You can just say that it was at or near the time of death?
 - A Yes. I can only say that they were perimortem.
- Q Nor can you go through and outline the order in which the injuries were caused and which one ultimately caused the death?
 - A Yes, I can -- that's right.
- Q Okay. And it's a little bit different when you deal with bruising. Have you ever had -- have you ever been called upon to date an injury based upon the bruising that is present?

And Nicolin is a convicted felon. And her -- one of her felonies is a drug felony from 2006. And just very briefly, what happens is that she is staying, I believe, in the Sportsman's. And Metro does a -- they do a controlled buy. Based upon that controlled buy, they serve a search warrant on her apartment at the Sportsman's. And she is in there with drugs.

Mr. Malone is also present in that unit. The police take her out. They take Mr. Malone out. And the Metro detectives asked Nicolin, you know, what the defendant was doing in there, whether he was involved in the drugs.

In reality, they were the defendant's drugs. It was the defendant's -- or certainly, would have been on the hook

for some of that stuff, legally.

They want Nicolin to agree to testify against the defendant. And in exchange for that, they tell her, we'll dismiss the charges, you'll be out of it. And it's the standard, you know, police are always trying to get to the supplier, to the supplier. She refused to do that. She didn't want to do it.

And based upon that she gets arrested and suffers her felony conviction. And she does have a felony conviction from 2006, stemming from these events. The only reason -- and I didn't know that before. Mr. DiGiacomo told me that Nicolin had brought it up to him this morning.

So, I can tell the Court, that's not something that I intend to get into in my direct examination. The only relevance that I think it might have is we've heard Mr. Pike's opening, and we've heard some of the other cross-examination. And there is this theory that exists that maybe Trey is somehow involved in these murders.

And my recollection from the previous trial is that Nicolin was cross-examined on her allegiance to Trey. And the suggestion is, she's going to lie, or she's not going to be truthful in order to help protect Trey from any involvement in this case.

If that's the thrust of the cross-examination here, because it is Domonic Malone who's on trial, there is

relevance then to the fact that she has also tried to protect this defendant before by not cooperating with the police, by not telling the police of his involvement in that drug incident, that drug event, so much so that she suffered her first felony conviction as a result of it.

So, I don't -- again, I don't intend to go there.

There are ways I think that that fact could become relevant based upon the defense cross-examination. So, out of an abundance of caution, Mr. DiGiacomo and I felt we certainly needed to tell the defense so they're aware that it's out there and then they can proceed however they want. But I also wanted the Court to be aware of it as well.

THE COURT: All right. Mr. Cano?

MR. CANO: Yes, Your Honor. I don't know if Mr. Lalli had mentioned it. But I think that there -- it wasn't just Mr. Malone that was inside that room. I think that Trey was also inside of there, as well as some other person named I think Jeff -- or I don't recall that name. But there were a couple of other people that were inside of that room as well regarding this incident. And we gathered that information from speaking with Ms. Broderway just in the hallway right now.

Now, as far as, you know, the relevance and the bias that goes into this case, I mean, I'm not sure if it is. I mean, my intent wasn't to go into any details of that

conviction, other than to obviously inquire -- the proper [inaudible] that need to be inquired as to the fact that she has a felony conviction, and what it's for, and when did it happen, obviously.

And as far as what was testified to at the previous trial and her statements, they contain some -- they contain some knowledge of what -- they contain some statements regarding from her activities, or from her involvement in this that, you know, obviously she had been working for Trey, and considers him some type of a boss or a bigwig. I think that's a proper avenue. I don't think that necessarily opens the door to any bias against Mr. Malone, per say.

As well as I think there's some areas in her testimony where she had tried to contact Trey to see his involvement in this case. Nothing about covering up for him, or lying about him, to my recollection in here. But that wasn't necessarily the intent. I mean, I think the things that I mentioned are perfectly fine to go into, obviously, in my cross-examination.

THE COURT: Well, are you going to get into issues of her trying to protect Trey?

MR. CANO: That was -- that's not necessarily my intent to go into that area. Obviously, I was going to go into the areas of like what her connection is with Trey, and what her involvement was with Trey in the time in question.

THE COURT: You mean, Trey sells drugs or doesn't sell drugs, sells women or doesn't sell women; those types of things?

MR. CANO: Right. And she also tried to contact Trey regarding this case as well.

MR. LALLI: It's a little more extensive than that. I mean, I think, if I'm not mistaken, she might refer to Trey as the "shot-caller."

MR. CANO: Right.

MR. LALLI: Which means, he's the guy who's in charge. And that was kind of the theme of -- I believe it was Mr. Sgro's or Mr. Oram's cross-examination at the last trial. And so, the whole idea is Trey's in charge. And so people who are working for Trey -- the inference is that people who are working for Trey are going to cover it up, or are going to make it look like Trey is not involved.

And so, I think if they go there -- you know, I haven't heard Mr. Cano's questions. I don't know exactly what he's going to ask or how he's going to do it. But if there is that suggestion, then the fact that she suffered a felony conviction of herself, which is a big deal, so that Mr. Malone doesn't get tied up in this case, I think that's relevant.

MR. CANO: Well, she didn't say that he was -- I mean, she says he's the big boss here. I mean, it's her perception of what she told the police, as well as to what she testified to, Your Honor.

Obviously, you know, now she's saying there was another incident when I got arrested where the drug interest is these two people, that they were working together, I think is what she said, if I recall correctly. So, I don't think she made a distinction as to who was the big boss or who wasn't the big boss, other than Domonic and Trey were working together and they had an interest in the drugs.

And without having details of like a police report or some kind of information, I don't know if it's proper, you know, that -- I don't think I'm opening any doors by asking those questions, first off.

And I think I might have -- I think both of us are at a disadvantage about going into that area blindly, without any kind of reports or anything to, you know, be able to effectively cross-examine her, and effectively to give her -- you know, to elicit any kind of testimony regarding that.

THE COURT: Is it your intent to ask her about the drugs involving her arrest, or drugs on some prior date?

MR. CANO: No. I wasn't even going to go into the facts or the specifics behind her felonies. I know she has three different felonies.

THE COURT: That's all you can ask, is what was it, when, and --

MR. CANO: And what for.

18 THE COURT: Right.

MR. CANO: Exactly. And that's -- you know, I anticipate that the State will probably get into that. If they don't, I definitely will.

So, I guess -- you know, that's -- we have to back up there. And what's the relevance of Trey being the shot-caller, the big leader of the pyramid? I mean, what's the relevance of that?

THE COURT: Mr. Cano?

MR. CANO: Well, Your Honor, it's completely relevant as to this case in general. I mean, if he's involved in this case, which it appears from, you know, the discovery that we have, and the statements given and prior testimony it involves -- that there is some type of involvement, or some type of knowledge attributed to Trey regarding these incidents

MR. CANO: The drug -- she's involved with him because of the drug transactions. In her -- and I'm not going to misstate, you know, what she says in her statements. But to my understanding of what she said in her statements, she's referring to some type of -- the drug involvement, and that he is the big boss, and that he's the shot-caller.

THE COURT: Okay. How does that relate to the two victims here? Is there any evidence that he had a beef with the two victims?

MR. CANO: Your Honor, it's totally -- it totally relates to her, as to her knowledge of all the players in this -- you know, in this transaction. And it also relates that if he is a boss or a shot-caller and he has knowledge of this murder, there is some involvement of him in this case. And I think that's completely proper for us to go into our defense, you know, that we can go into that area. It's completely relevant.

THE COURT: I didn't hear the answer to my question. Do you have any evidence linking him to the murders?

MR. CANO: Do I have any evidence linking him to the murders? Court's indulgence, Your Honor.

THE COURT: Okay.

(Pause in the proceedings)

MR. CANO: There's evidence that he was -- he had -- you know, the apartment at the South Cove that was just a few doors down --

THE COURT: Okay.

MR. CANO: -- from where these girls were taken.

Obviously, you know, there is evidence that he was involved in the drug trade. And I think that there is some statements regarding that some money was owed to him, involving the girls as well. So, there are some links, yes.

MR. LALLI: The money was owed to the defendant, for starters. With respect to the fact that Trey was involved in this murder because he, you know, was staying a few doors down from where the girls were abducted, Mr. Cano objected to some of the things that Sarah Matthews testified to as hearsay. And I don't begrudge him for that. But what she had said -- and the Court ultimately struck it.

But what she said was that Trey was telling Mr.

Malone, forget about the girls, forget about it. I can

represent as an officer of the Court, when Ramaan Hall, Trey,

testified at the last trial, totally consistent with his account of what happened. He was actually having the conversation with the defendant.

And this is all borne out in the transcript of Mr. McCarty's trial. He's telling the defendant, why are you bothering with these women? They're prostitutes, they're — of course they're going to ingest your drugs. I mean, what else would you expect? Forget about them, leave them alone.

So, I don't think you can argue that merely because of proximity here -- imagine -- how would you like to -- when you were in your defense attorney days, how would you like to defend that guy in this murder case? I'd love it if I were a defense attorney, because there is no evidence that links --

THE COURT: Then why aren't we bringing in evidence that the guy who lived on the third floor is a drug dealer? You know, because then he could have had a motive to kill these ladies. I mean, because do we have any evidence that these ladies stole Trey Black's drugs? Or had -- you know --

MR. CANO: Your Honor --

THE COURT: -- didn't return them?

MR. CANO: -- we don't know what's inside of Trey's head, because he hasn't testified yet. If he comes up here and testifies, we'll be prepared to cross-examine him, whether his involvement, or lack of involvement, or whatever his role is in all of this.

THE COURT: When is he --

MR. CANO: And it's not our obligation to -- you know, we have a right to defend Mr. Malone in this case.

THE COURT: Absolutely, you do.

MR. CANO: And you know, obviously, you know, we're defending him through the discovery that, you know, we were provided in this case. And part of that discovery does link knowledge to Trey regarding this incident, as well as whether monies were owed to him or not owed to him.

And actually, this witness -- I actually asked that question from Ms. Estores, whether she had told this witness specifically -- and which I'm assuming we're probably going to get into here in a minute whether she had -- whether Ms. Estores had told her about Trey's involvement in this case, and that monies were owed to him.

And she relayed that in her statement to the police. And upon that she contacted Trey to find out what his involvement was. And he made admissions regarding -- to her regarding, you know, that involvement in the time in question. So, there are links that ties him to this case, you know, in addition to the proximity to everything.

And he does have a relationship -- not -- you know, with her, as well as with, you know, several other people, you know, regarding the drug ring that, you know, Ms. Estores had testified to earlier, and what we've been able to elicit.
