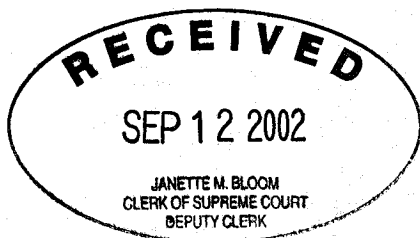

DAYVID J. FIGLER, having been first duly sworn, and upon information and belief, deposes and says:



2. That Respondent filed their Supplemental Answering Brief on August 27, 2002.


3. That Appellant's Supplemental Reply Brief is currently due on or before September 13, 2002.

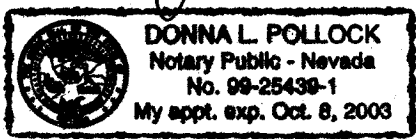
