I. INTRODUCTION

This Emergency Motion seeks to extend the time for Real Party in Interest, Scott Financial Corporation ("SFC") to file its Answer to Petitioners' Writ, and Supplement ("Answer"), which is currently due on February 14, 2013.

II. THE REQUIREMENTS OF NRAP 31(b)(3)(A)

As set forth in the attached NRAP 27(e) Certificate of Counsel, SFC seeks a thirty (30) day extension to file its Answer pursuant to NRAP 26(b)(1)(B) and NRAP 31(b).

- (i) The date when the Answer is due:
- The Answer is currently due February 14, 2013.
- (ii) The number of extensions of time previously granted (including a five-day (5) telephonic extension), and if extensions were granted, the original day when the Answer was due:

Originally, SFC's Answer was due on October 17, 2012, pursuant to this Court's September 17, 2012 Order Directing Answer. Thereafter, Petitioners and SFC submitted a stipulation to this Court extending the time for SFC to file its Answer until November 19, 2012.

On or about October 25, 2012 this Court issued an Opinion in the case of <u>In re Fountainbleau Las Vegas Holdings</u> 128 Nev. Adv. Op .No. 53, which Petitioners claim may have an implication in the current Writ before the Court. Following the <u>Fountainbleau</u> decision Petitioners and SFC filed a Joint Motion to Allow the Petitioners to File a Supplement to the Writ and Amend the Briefing Schedule. This Joint Motion was granted, thus rendering the Petitioner's Supplemental Brief due on September 31, 2012, SFC's Answer due on February 14, 2013, and Petitioner's Reply due on March 18, 2013.

(iii) Whether any previous requests for extensions of time have been denied or denied in part:

No previous requests for extensions have been denied.

(iv) The reason or grounds why an extension is necessary:

Good cause can be shown for an extension in this case. SFC, after receiving Petitioner's Supplemental Writ, elected to hire additional counsel to assist with the Answer, namely Hutchison & Steffen, LLC ("H&S"). Upon information and belief H&S will file a Notice of Association of Counsel contemporaneously with the filing of this Motion. In order to provide new counsel with sufficient time to become familiar with the issues involved in this case and to draft the Answer, an additional thirty (30) day extension is warranted. Furthermore, Petitioners are agreeable to allowing for such an extension.

(v) The length of the extension requested and the date on which the Brief will become due:

SFC requests a thirty (30) day extension which would make the Answer due on or before March 18, 2013. Petitioners would then have an additional thirty (30) days to file a Reply Brief should they elect to do so. The Reply Brief would be due on or before April 17, 2013.

SFC respectfully requests that this Motion be granted and it be allowed an additional thirty (30) days up to and including March 18, 2013, in which to file its Answer.
