Re: ADKT 0478--In the Matter of Amendments to SCR 210 Regarding Minimum CLE Requirements and Making Mandatory CLE in Substance Abuse, Addictive Disorders &/or Mental Health Issues

Dear Ms. Lindeman:

At yesterday's public hearing regarding ADKT 0478, Justice Hardesty requested information regarding the number of CLE credits required by other jurisdictions. CLE Board staff conducted the requested research, reviewing the CLE requirements of jurisdictions that have mandatory continuing legal education. The results are attached (note that not all states have mandatory CLE; also, the list includes Qeubec and Puerto Rico).

The number of credits listed is the number required annually, unless otherwise noted: a few jurisdictions have two- or three-year CLE requirements rather than annual requirements. In addition, jurisdictions that have a separate requirement akin to the one currently under consideration in ADKT 0478 are marked with a star. Finally, staff's tally on page three indicates that seven jurisdictions require 10 hours per year of MCLE; eighteen jurisdictions require 12 hours per year of MCLE; two jurisdictions require 12.5 hours per year of MCLE; and thirteen jurisdictions require 15 hours per year of MCLE. With 12 hours per year of MCLE, Nevada is about average in the number of hours required per year.

I hope the court finds this information to be useful.
