MOTION FOR LEAVE TO FILE AMICUS CURIAE BRIEF AND TO BE HEARD AT ORAL ARGUMENT

The Livery Operators Association of Las Vegas ("LOA") respectfully moves this Court for leave to file the brief submitted herewith, as *amicus curiae* in support of Respondents Nevada Yellow Cab Corporation, Nevada Checker Cab Corporation, and Nevada Star Cab Corporation. *Amicus curiae* counsel also respectfully request to be given the opportunity to be heard at the time of the oral argument as to issues that will directly affect the members of the LOA, as well as other commercial motor carriers which will be impacted by this Court's ruling.
