21 **STIPULATION TO STAY APPEAL AND BRIEFING FOR NINETY DAYS PENDING**  
22 **ENTRY OF FINAL JUDGMENT**

23 Plaintiff, CASHMAN EQUIPMENT COMPANY, by and through its counsel of record,  
24 Jennifer R. Lloyd, Esq.; Defendants, THE WHITING TURNER CONTRACTING COMPANY,

28 Brian Boschee, Esq., hereby stipulate and agree as follows:

1. The underlying matter proceeded to trial on January 21, 2014. The district court issued its decision on January 24, 2012. A copy of the minutes of the decision is attached hereto as Exhibit "1". The district court's decision has not yet been reduced to Findings of Fact and Conclusions of Law and Judgment. The Parties are working diligently to complete that task.
2. The district court's decision at trial involves the issue pending before this Court, in that the district court's decision includes, at least in part, the relief that had been sought by Respondents in the Motion to Procure Codes, the granting of which is the subject of this appeal. This appeal arises out of the issuance of a preliminary injunction, which is an immediately appealable order pursuant to Nevada Rules of Appellate Procedure 3A(b)(3).
3. In the interest of judicial economy and so as to avoid duplicative briefing, the Parties have agreed to stay this appeal and briefing for a period of ninety days pending the entry of Judgment after trial in the underlying matter.
