23 **MOTION VOLUNTARILY TO WITHDRAW APPEAL**

24 Mitchell David Stipp, appellant/cross-respondent named above ("Mitchell"), hereby moves  
25 voluntarily to withdraw his appeal docketed in the Nevada Supreme Court as Case No. 62299.

26 The primary purpose of Mitchell's appeal was to review the district court's denial of the review  
27 of child support under NRS 125B.145(1)(b). Christina Calderon Stipp, respondent/cross-appellant, has  
28 filed an action with the State of Nevada, Department of Human Resources, Welfare Division, Child

1 Support Enforcement Program, as part of the Office of the Clark County District Attorney's Office (the  
2 "Family Support Division"), to have Mitchell's child support obligations reviewed. While the denial of  
3 review by the district court may have been in error, Mitchell believes the Family Support Division will  
4 address the issue. Accordingly, there is no practical purpose of pursuing the appeal.

6 **VERIFICATION**

7 I, Mitchell Stipp, as appellant/cross-respondent and co-counsel of record, understand the legal  
8 effects and consequences of this voluntary withdrawal of appeal, including that I cannot hereafter seek  
9 to reinstate this appeal and that any issues that were or could have been brought in this appeal are  
10 forever waived. With this knowledge, I hereby respectfully request and consent to a voluntary dismissal  
11 of the above-mentioned appeal.

15 may sanction an attorney for failing to file such a notice. I therefore certify that the information
