

Plaintiff, Las Vegas Metropolitan Police Department ("LVMPD"), filed its Motion to Settle the Record Pursuant to NRAP 10(c) on September 5, 2014, and the Supplement to LVMPD's Motion to Settle the Record Pursuant to NRAP 10(c) on October 7, 2014.
