**RESPONSE TO  
NOTICE OF POTENTIAL DISMISSAL  
FOR FAILURE TO PAY SUPREME COURT FILING FEE**

Comes Now, Appellant Nadine Goodwin and files her response to the Notice Of Potential Dismissal For Failure To Pay Supreme Court Filing Fee that was filed by the Office of the Clerk on January 24<sup>th</sup>, 2013 in this matter.

This is an appeal from the denial of a Petition of Judicial Review where Appellant Nadine Goodwin sought review of her being denied unemployment benefits under Chapter 612 of the Nevada Revised Statutes. Pursuant to N.R.S. § 612.705(1), no filing fee may be charged by any court for anyone seeking unemployment benefits through any court.

No person claiming benefits may be charged fees of any kind in any proceeding under this chapter by the Board of Review, the Administrator, or representatives of the Board of Review or the Administrator, or by any court or officer thereof. (emphasis added)  
N.R.S. § 612.705(1)

Ms. Goodwin's Notice of Appeal references this statute and that no filing fees are to be charged.

The undersigned has appealed other denial of petitions for judicial reviews regarding the denial of unemployment benefits and Supreme Court filing fees were not charged in those cases. Based on this statute and the previous appeals filed by the undersigned where filing fees were not

1 charged for cases involving the denial of unemployment benefits, the filing fee was not paid in this  
2 matter. Therefore it is requested that this legal issue be determined prior to Ms. Goodwin being  
3 required to pay a filing fee and that her case not be dismissed pending this determination. If this  
4 Court determines that a filing fee is required in this matter it will be immediately paid.
