APPELLANT'S MOTION TO PARTIALLY STRIKE OR ALTERNATIVELY TRAVERSE OR OBJECT TO NOTICE OF PENDENCY OF BANKRUPTCY FOR CAESARS ENTERTAINMENT OPERATIONG COMPANY, INC., *ET AL.* AND AUTOMATIC STAY OF PROCEEDINGS FILED MARCH 18, 2015

NOW COMES Appellant, Dr. Joel Slade, and herewith traverses the Notice of Suggestion of Pendency of Bankruptcy for Caesars Entertainment Operating Company, Inc., et al. and Automatic Stay of Proceedings ("Notice"). This Motion and Traverse is based upon the pleadings and papers on file to date, the pleadings and papers filed in U.S. Bankruptcy Court, Northern District of Illinois, and the following Memorandum of Points and Authorities.

Through this Traverse, Appellant requests that the appeal against Paris Las Vegas Operating Company, LLC ("Paris"), and if applicable, Caesars Entertainment Corporation ("Caesars, Corp."), not be stayed during the pendency of the bankruptcy cited by the Appellees. Further in this respect, Appellees should be required to file a more definite statement concerning Appellee, Caesars, Corp. Nothing herein challenges the automatic stay concerning, nor seeks to further prosecute proceedings against, Caesars Entertainment Operating Company, Inc.

MEMORANDUM OF POINTS AND AUTHORITIES

A. FACTS AND BACKGROUND

Appellee, Caesars Entertainment Operating Company, LLC, filed bankruptcy in the Northern District of Illinois. The notice filed by Appellees herein states in relevant part, "CAESARS ENTERTAINMENT OPERATING COMPANY, INC. and certain of its subsidiaries and affiliates . . . [including Debtors involved in this specific case . . .], filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code " Notice, p. 2: 2-5 (brackets in original). Through this, Appellees appear to seek a stay of all proceedings in this Court.

In fact, it appears that both Caesars, Corp., and Paris are not debtors in Bankruptcy.

Appellees cite to Schedule 1 in the bankruptcy petition they file for the proof that Paris and Caesars, Corp., are debtors. There is no Schedule 1, although there is a Rider 1 that appears to be what the Appellees reference. A copy is attached hereto as exhibit 1. Neither Paris nor Caesars, Corp., appear on this list as the Appellees represent.

Appellees also refer the court to a web site for further information. Notice, n.1. Working through this web site, one will arrive upon the document attached as exhibit 2, and setting forth the scope of the bankruptcy filing at issue. Pertinent in exhibit 2 is the fact that Appellee, Paris, is expressly "excluded" from the bankruptcy.

The docket in the Northern District of Illinois Bankruptcy Court also appears to include a list of all entities encompassed in the bankruptcy at issue. This is attached as exhibit 3.

Again, neither Caesars, Corp., nor Paris are included in the list.

Finally, the financial paper of record for the United States, the Wall Street Journal, reported on the bankruptcy of Caesars Entertainment Operating Company, LLC. The pertinent article begins by noting that Caesars, Corp., placed its "largest unit" into bankruptcy in

reference to the bankruptcy at issue. That is, Caesars, Corp., as a holding company, caused Caesars Entertainment Operation Company, LLC to file bankruptcy. This would, by necessary implication, exclude a bankruptcy by Caesars, Corp. See http://www.wsj.com/articles/caesars-unit-files-for-chapter-11-bankruptcy-1421306807 (viewed 3/26/15). The article goes on to say that, "Properties such as the Playboy Club London and some Caesars properties in Las Vegas, including the Harrah's, Paris and Bally's casinos, aren"t part of the bankruptcy filing." (Emphasis added).

It appears that the Appellees' statement that Caesars, Corp., and Paris filed proceedings in Bankruptcy Court, or are in any way included within the parties affected by the bankruptcy of Caesars, Corp., are patently false. These false statements are material to the operation of the stay and the effect of the notice, and as shown below, no stay is warranted or appropriate as to these parties.

II. ANALYSIS

It is clear in Nevada that the automatic bankruptcy stay does not apply to co-debtors and guarantors. *Edwards v. Ghandour*, 123 Nev. 105, 113–14 & n. 10, 159 P.3d 1086, 1091–92 & n. 10 (2007) partially abrogated on other grounds by Five Star Capital Corp. v. Ruby, 124 Nev. 1048, 1053–54, 194 P.3d 709, 712–13 (2008). Here, one of but three co-defendants have filed for bankruptcy. Obviously, under Nevada law, the action, and therefore the appeal, concerning Caesars, Corp., and Paris are unaffected by the bankruptcy of Caesars Entertainment Operating Company, LLC.

In this sense the current stay concerning Caesars Entertainment Operating Company,

LLC, has little or no effect on the status and ripeness of the present matter for decision. The

matter is fully briefed, and oral argument has occurred. The net effect of the bankruptcy is that
the decision of this court should be limited to Caesars, Corp., and Paris. Appellee is entitled to

such a decision, per Nevada law Appellee is entitled to have his case proceed against the two non-bankrupt co-defendants, and other than deleting Caesars Entertainment Operating Company for the decision, nothing in the orderly processes of this Court should be affected.

III. CONCLUSION

For the reasons set forth above, Appellee requests that the Notice be disregarded as to Appellants Caesars, Corp., and Paris, and that a decision enter in this matter in the ordinary course.
