3 Court to clarify its Order Granting Motion for Leave to File Amicus Curiae Brief,  
4 which was entered on January 6, 2014.

6 On January 6, 2014, the Court also entered its Order Granting Community  
7 Association Management Executive Officers, Inc.'s (CAMEO) Motion for Leave to  
8 File Amicus Curiae Brief. However, the language in the Order is vague as to the  
9 briefing deadlines for the Amicus Curiae Brief, and does not appear to comport with  
10 NRAP 29(f), which states in part, "The court may grant leave for later filing,  
11 specifying the time within which an opposing party may answer." In this case, the  
12 Order merely states that Respondent "may respond to amicus brief in its answering  
13 brief", however, the filing deadline for the answering brief had already lapsed.

15 Based on the above, and Respondent seeks clarification from this Court  
16 regarding its Order Granting Motion for Leave to File Amicus Curiae Brief, and  
17 respectfully requests the Court specify the filing deadline for an answer the Amicus  
18 Curiae Brief. This Motion is made in good faith and without the intent to cause  
19 unnecessary delay in this appeal.
