On January 6, 2014, the Court also entered its Order Granting Community Association Management Executive Officers, Inc.'s (CAMEO) Motion for Leave to File Amicus Curiae Brief. However, the language in the Order is vague as to the briefing deadlines for the Amicus Curiae Brief, and does not appear to comport with NRAP 29(f), which states in part, "The court may grant leave for later filing, specifying the time within which an opposing party may answer."
