and Civil Proper Person Transcript Request Form.

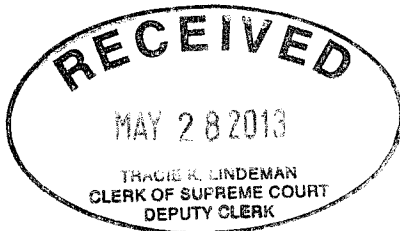
