

ORDER GRANTING MOTION FOR STAY

This is an appeal from a district court order dismissing a
petition for judicial review and appellants' objections to a decision by the
State Board of Equalization in a tax matter.


Certain appellants (referred to as the Village League appellants) have filed a motion to stay the district court's July 1, 2013, dismissal order, which also lifted a partial stay that prohibited the State Board of Equalization from conducting any reappraisals of residential properties in Incline Village or Crystal Bay. The State of Nevada and Washoe County respondents have separately filed nonoppositions to this stay motion, and respondents Pershing County Assessor and Churchill County Assessor have not filed any opposition to the motion.

Given that the stay motion here is unopposed and, having considered the motion in light of the relevant factors, we conclude that a stay is warranted in this case. *See* NRAP 8(c). Accordingly, we grant the motion and stay the July 1, 2013, order entered in District Court Case No. CV03-06922 pending resolution of this appeal.

It is so ORDERED.
