





**DECLARATION OF SUELLEN FULSTONE IN SUPPORT OF MOTION
FOR AN EXTENSION OF TIME FOR FILING REPLY BRIEF**

I, Suellen Fulstone, state, under penalty of perjury, as follows:

1. I am an attorney duly licensed to appear in the courts of the State of Nevada and am employed part-time with the law firm of Snell & Wilmer, counsel for the Village League appellants in the appeal captioned "*Village League to Save Incline Assets, Inc. v. The State Board of Equalization, et al.*," Appeal No. 63581 in the Nevada Supreme Court.

2. I prepared the opening brief for the Village League appellants and am primarily responsible for the preparation of the reply brief in the above-identified appeal. That reply brief is presently due on March 17, 2014. The reply brief of the Bakst appellants is also due on March 17, 2014.

3. In the process of transitioning from my legal practice to a career as a teacher, I have continued to find it difficult to find the blocks of time necessary to research and draft the reply brief in this matter. I have now taken a hiatus from teaching so that I can focus on and complete the brief. My next scheduled teaching date is March 27, 2014. On behalf of the Village League appellants, I am seeking an additional nine-day extension on the reply brief to March 26, 2014. That would be the second extension for a total of 50 days on the reply to the SBOE Answering Brief and 36 days on the reply to the County Answering Brief.

4. All counsel have agreed that the time for the Bakst appellants to file their reply brief would be similarly extended. Counsel previously agreed and have stipulated that the Village League appellants will file a single reply brief to both the SBOE and County Answering Briefs.

5. If the requested extension is granted, both reply briefs will be due on the same day, March 26, 2014, and the appeal will be fully briefed at that time.


This extension is requested to accommodate certain personal issues of


