DECLARATION OF SUELLEN FULSTONE IN SUPPORT OF MOTION FOR AN EXTENSION OF TIME FOR FILING REPLY BRIEF

I, Suellen Fulstone, state, under penalty of perjury, as follows:

1. I am an attorney duly licensed to appear in the courts of the State of Nevada and am employed part-time with the law firm of Snell & Wilmer, counsel for the Village League appellants in the appeal captioned "*Village League to Save Incline Assets, Inc. v.
