17 The within action having come before the Court upon Motion for Trial Transcript and
18 Court File Copies at Public Expense filed by David R. Houston on behalf of Ernesto

20 Defendant filed an appeal to the Nevada Supreme Court on October 15, 2013.
21 David R. Houston and the Law Office of David R. Houston and Kenneth E. Lyon, III, were
22 relieved as counsel of record for the Defendant, Ernesto Gonzalez, on his appeal by the
23 Nevada Supreme Court on January 13, 2014. In addition, the Nevada Supreme Court
24 remanded the matter to this Court for the limited purpose of appointing counsel if
25 Defendant was indigent.

26 Subsequently, this Court entered an order finding the Defendant indigent and
27 pursuant to NRS 7.115 ordered the Washoe County Public Defender's Office appointed to
28 represent Ernesto Gonzalez in connection with his appeal to the Supreme Court of
Nevada.
