
IT IS FURTHER ORDERED that Clark County Public Defender Darin Imlay be appointed to the Commission to replace Philip Kohn who has since retired; and


IT IS FURTHER ORDERED that Lisa Rasmussen, JoNell Thomas, and John Springgate be appointed to the Commission; and


IT IS FURTHER ORDERED that the individuals listed in Exhibit A constitute the membership of the Commission on Statewide Rules of Criminal Procedure.


