ORDER GRANTING MOTION

On June 27, 2014, this court entered an order directing respondents California Back Specialists Medical Group, Inc., California Minimally Invasive Surgery Center, Conejo Neurological Medical Group, Inc., Medical Imaging Medical Group, and Thousand Oaks Spine Medical Group, Inc. (the Chiu Entities)¹ to retain counsel and cause counsel to

enter an appearance within 45 days of the date of that order. On June 30, 2014, appellant filed a certificate of service of that order on the Chiu Entities. The order stated that if the Chiu Entities did not respond, it would be assumed that they were proceeding in proper person. The order further noted that "business entities are not permitted to . . . file documents, in proper person," *State v. Stu's Bail Bonds*, 115 Nev. 436, 436 n.1, 991 P.2d 469, 470 n.1 (1999).

To date, the Chiu Entities have not responded to this court's order. Appellant has filed a motion to preclude the unrepresented Chiu Entities from filing documents or otherwise participating in this appeal. Cause appearing, we grant the motion. The Chiu Entities are precluded from filing any documents in this appeal, including a joinder to any brief filed by another respondent, or otherwise participating in this appeal.

It is so ORDERED.
