### REQUEST FOR TRANSCRIPTS OF PROCEEDINGS

Pursuant to NRAP 9(a)(3)(A), appellant, DeAngelo R. Carroll, hereby files one (1) file-stamped copy of the Request for Transcript of Proceedings served on the following court recorders/reporters:

- 1. Janie Olsen (Exhibit 1);
- 2. Maureen Schorn (Exhibit 2); and
- 3. Renee Vincent (Exhibit 3).<sup>1</sup>

Please note these are not the only transcripts Carroll needs, or may need, for this appeal. This is a large/voluminous murder case, involving six (6) defendants. The case began in 2005. It was originally assigned to judge Donald Mosley. Judge Mosley is no longer on the

bench. Judge Mosley had two court reporters — Maureen Schorn and Joe D'Amato — who alternated reporting proceedings for him. Ms. Schorn informed undersigned counsel today that D'Amato passed away two years ago. Since he was a court reporter, not a court recorder, it is unlikely transcripts can be prepared now of the hearings D'Amato covered, unless the transcripts were prepared and filed before he passed away. The transcripts Carroll needs that D'Amato reported are for hearings held on 8/4/2005, 12/5/2005, 3/17/2006, 6/26/2006, 6/30/2006, and 9/8/2006.

Counsel has requested copies of all documents, including all transcripts, filed in the district court. The district court clerk's office prepared a disk containing these documents and mailed it to counsel yesterday. Once counsel receives the disk and reviews its contents, he will let the court know if the transcripts of these D'Amato hearings are already part of the record.

If they aren't, the parties may need to engage in NRAP 9(c) proceedings/procedures. In the meantime, counsel will continue to work with the district court to see if recordings of the D'Amato hearings

exist so they can be transcribed, and to figure out who would be responsible for, or would be willing to, transcribe them. If recordings exist and can be transcribed, Carroll will then file a supplemental request for transcript of proceedings with the court.




