MEMORANDUM AND POINTS OF AUTHORITIES

I. INTRODUCTION

Respondent respectfully requests an extension of thirty (30) days from February 25, 2015 upon which to file its Answering Brief and Appendix. On March 4, 2014, the District Court for Clark County, Nevada entered Findings of Fact and conclusions of Law granting summary judgment in favor of Respondent. A notice of Entry of Order was filed on March 7, 2014. Appellants filed a timely Notice of Appeal on March 25, 2014. On December 12, 2014, Appellants filed their Motion for Enlargement of Time (First Request). This Court granted Appellants' Motion thereby extending the deadline by which Appellants were required to submit their Opening Brief and Appendix to January 26, 2015. Thereafter, Appellants filed their Opening Brief and Appendix on January 26, 2015.

II. LEGAL STANDARD

Pursuant to N.R.A.P. 26(b), this Court may extend the time prescribed by the Nevada Rules Of Appellate Procedure to perform any act, or may permit an act to be done after such time expires. N.R.A.P. 26.

III. DISCUSSION


IV. CONCLUSION


