**STIPULATION TO EXTEND  
DEADLINES FOR FILING**

**(First Request)**

Pursuant to NRAP 31(b)(2), this Stipulation is made and entered into  
between Petitioner Corporation of the Presiding Bishop of the Church of  
Jesus Christ of Latter-Day Saints on behalf of Cleveland Ranch, and Real

Parties in Interest Jason King, P.E., in his official capacity as the Nevada State Engineer, and the Nevada Department of Conservation and Natural Resources, Division of Water Resources; and Southern Nevada Water Authority. Other interested parties, White Pine County, et al.; Confederated Tribes of the Goshute Reservation; Ely Shoshone Tribe; Duckwater Shoshone Tribe; Millard County, Utah; and Juab County, Utah, also join in this Stipulation.

On July 2, 2014, the Court set a briefing Schedule in its Order Directing Answer, with the answering briefs of the real parties in interest due within 30 days of entry of the order, and the reply brief of the petitioner due 15 days thereafter.

Counsel have discussed among themselves and consulted with their respective clients and determined that 30-day extensions in the parties' briefing schedule will not prejudice any party and will permit each of the parties to better prepare their briefs.

As a result, the parties, through their respective counsel, hereby stipulate and agree as follows:

1. The deadline for filing the Answering Briefs of the Real Parties in Interest will be extended from August 1, 2014, until September 2, 2014; and

2. The deadline for filing the Reply Brief of the Petitioner will be extended from August 16, 2014, until October 3, 2014.




