## JOINT RESPONSE TO SUPREME COURT'S ORDER TO SHOW CAUSE

First Light Homeowner's Association and D.R. Horton, Inc. (collectively the "Parties") 3 4 file this Joint Response to the Supreme Court's Order to Show Cause filed on July 22, 2015. 5 On July 3, 2014, Petitioner D.R. Horton, Inc. filed a Petition for Writ of Prohibition 6 and/or Mandamus (the "Petitioner") in Docket No. 65993.

On December 10, 2014, the Supreme Court issued an Order consolidating this case with 8 Docket No. 65456 (wherein D.R. Horton is the Real-Party-In-Interest) for the purpose of oral 9 argument only which was heard on January 7, 2015. The Court has not rendered its decision 10 11 on the Consolidated Petitions.

12 On July 13, 2015, the Parties filed a Joint Notice of Pending Settlement and Motion to 13 Stay Decision in Docket No. 65993 informing the Supreme Court of a tentative settlement (the 14 "Settlement") reached by the Parties and subcontractors, and requesting the Court stay the 15 issuance of its decision on Docket No. 65993 only pending approval of the Settlement by the 16 District Court. Once approved, the Parties intend to file a dismissal of the Petition in Docket 17 No 65993 only. The Settlement and the Request have no impact on Docket 65456 (underlying 18 19 case High Noon at Arlington Ranch Homeowner's Association v. D.R. Horton, Inc.) and the 20 Supreme Court's pending decision. D.R. Horton requests this Court move forward with 21 issuance of the decision in that matter.

The Parties agreed upon the terms and language of the Settlement as well as the 23 language and terms of a Joint Motion seeking approval of the Settlement. Both documents are 24 being circulated to the subcontractors for approval and a status hearing is set for July 30, 2015 25 at which time it is likely a hearing date will be set on the approval of the Settlement. The Parties 26 27 will notify this Court once the hearing date is set.

Should the District Court not approve the Settlement, the Parties will further notify the 1 Supreme Court and request the Stay be lifted. The Settlement has no impact on Docket No. 2 65456 which is still being litigated and is set for trial. 3 4 DATED this 29 day of July, 2015.
