1. On or about the 11th day of July, 2014, the District Court Clerk, Steven

- D. Grierson, submitted his Certification of Copy and Transmittal of Record pursuant to the Order of this Honorable Court dated July 7, 2014.
- 2. The foregoing Certification reported that the Record on Appeal for this proceeding, at that time, consisted of nine volumes with pages numbered 1 through 1957 which, in Respondent's estimation, included all documents, minutes and transcripts which were of record in the District Court up to that point.
- 3. Respondent reports that, since the transmission of the Record on Appeal, the following events have occurred in this matter in the District Court proceeding:
 - a. On the 22nd day of July, 2014, Respondent filed his Objection to Motion by Judgment Creditor for an Order Directing the Issuance of a Writ of Execution.
 - b. On the 30th day of July, 2014, Respondent, ANGEL
