

Mr. Langford argued that the transcript is not clear as to what was said at trial and it is his recollection there was nothing mentioned as to why the dates came out incorrectly. Mr. Fattig advised Mr. Cristalli and his Investigator were allowed to go to the Henderson Crime Lab to look at the original reports. Following additional arguments, Court advised it is not satisfied that further discovery is needed at this time.

Further, copies of the fingerprint cards are to be released to show they were run in the AFIS system.

Following colloquy, Mr. Langford advised he will prepare the Order as to DNA testing. Court so noted and ORDERED, matter set for status check.
