- Plaintiff has failed to state a claim upon which relief can be granted, pursuant to NRCP 12(b)(5).
- Motion to Dismiss GRANTED pursuant to NRCP 12(b)(5) and Simpson v. Mars, 113 Nev. 188 (1991) and Vacation Village v. Hitachi America, 110 Nev. 481 (1994) and NRS 116.3116 and Diakonos Holdings, LLC v. Countrywide Home Loans, Inc. 2013, WL531092, Dist, Nec 2/11/13.
- 3. Request for Judicial Notice taken pursuant to EDCR 2.20 and NRS 47.130.
- 4. Countermotion to Stay proceedings DENIED for lack of authority, this ruling will not preclude Plaintiff's counsel from pursuing a stipulation and order for a stay should that be warranted and oral request for 54(b) Certification GRANTED pursuant to EDCR 2.20.
