

DANIEL F. POLSENBERG, being first duly sworn, deposes and says:



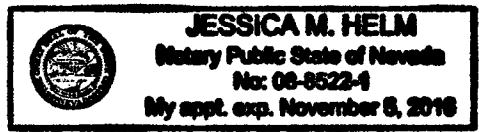
