6 1. On or about September 13, 2012, Appellant filed a Notice of Appeal

21 13, 2014.

22 7. The Notice of Entry of Judgment in the underlying District Court case  
23 was filed on August 21, 2014.

24 8. The Notice of Entry of Order Denying Cashman Equipment Company's  
25 Request for Costs Pursuant to NRS 18.020 in the underlying District Court case was  
26 filed on September 2, 2014.

27 9. On or about September 8, 2014, Appellant filed a Notice of Appeal on  
28 the Notice of Entry of Judgment and the Notice of Entry of Order Denying Cashman

1 Equipment Company's Request for Costs Pursuant to NRS 18.020, resulting in  
2 Supreme Court Case No. 66452.


3 10. The Parties now stipulate to consolidate Supreme Court Case No. 66452
