

25 14, & 15 - twelve months in CCDC as to each count with each count
26 running concurrent with each other, Ct. 5 - 10 years to Life in
27 prison, Ct. 5 to run concurrent with Cts. 1, 2 and 4; Ct. 6 - 10
28 years to Life in prison, Ct. 6 to run consecutive to Ct. 5; Ct. 10
10 years to Life in prison, Ct. 10 to run consecutive to Ct. 6;

1 Ct. 12 - 10 years to Life in prison, Ct. 12 to run concurrent with
2 Cts. 1, 2, 4, 6, 8, 10 & 11; 2,204 days CTS. Not Guilty Cts. 3 &


