#### **MEMORANDUM**

I, STEVEN S. OWENS, am a duly licensed attorney in the State of Nevada and am the supervising attorney for the above case on behalf of the State.

Petitioner Steven Dale Farmer has submitted a Petition for Rehearing following the Court's Order of Affirmance. The State's Answer is currently due on December 21, 2017.

The State requests 30 days, up to and including January 22, 2018, within which to file the State's Answer. Under Nevada Rule of Appellate Procedure 26(b)(1)(A), "[f]or good cause, the court may extend the time prescribed by these Rules or by its order to perform any act, or may permit an act to be done after that time expires."
