 - Yes, I believe so.
- You don't drive over there and drive back to Eastern and Ogden? 14
 - No, I never left.
 - When you're at Eastern and Ogden, what is it you do next after you speak to patrol officers and get a briefing?
 - Well, I was apprised that our ID personnel would be Α en route to my location. At that point, it's to ensure the integrity of the scene doesn't change, the doors to the vehicles aren't closed, nobody goes into the vehicles; just to kind of maintain the scene pending the next step in the investigation.
 - And what was the next step in the investigation at Eastern and Ogden?

13	physically give me a copy of the warrant.

I'm watching them do that. I witnessed I think it 21 was Crime Scene Analyst Cromwell recovered the gun under the 22 seat and unload it. 23 Okay. And then what happens next? 24 The -- well, the reason that we did that was so Α 25

we're not driving a vehicle to the crime lab with a loaded gun in it. At that point, they -- I believe they rolled up the windows. They put evidence seals on all the doors and the trunk, and made arrangements for a flatbed tow truck to come to our location so it could have been driven to the crime lab.

Q Let me ask you this question. In regard to the vehicle, once you secured the search warrant, did you know or

- vehicle, once you secured the search warrant, did you know or not know whether the car was going to be towed to another location?
 - A I don't believe that we knew at that point.
- Q Okay. But at some point, the decision is made to take the car to another location, is that correct?
- A Yes. I think one of the considerations would have been it was a busy street. We were kind of blocking traffic, narrowed traffic down to one lane northbound, so it just seemed more advantageous to move the vehicle.
- Q And the processing that is done at Eastern and Ogden then is not complete at that point?
 - A Oh, far from it. No.

- Q The car is then taken to Metro's crime -- Metro's garage, for lack of a better term, and then what happens once the car's taken there? Do you follow the car, or do you go to another location?
 - A No, I drove out there as well.
 - Q Okay. Once you get out to that location where the

car has been towed and the seals are intact, what happens 1 next? 2 Well, that's ID's job. They essentially tear the Α seals to get back into the vehicle. They start the 4 processing, which would be additional photographs taken, search the car for any potential evidence. б Okay. 7 I believe that they attempted to recover any latent 8 fingerprints on the vehicle. 9 And during this time, are you helping them to do 10 this, or are you sort of standing back and watching? 11 I'm merely watching. 12 Okay. A Well, I went to a medical school. I graduated from Oklahoma State University in 1978. I did a year of internship at Dallas Memorial Hospital. Then I was a general practitioner for ten years, and then I went back into pathology training at Michigan State University.

And then I did a one-year fellowship at the Cook County Medical Examiner's Office in Chicago, and I stayed there for some years. I'm board certified in anatomic pathology, clinical pathology, and forensic pathology. I've done about 10,000 autopsies.

Q And in regard to this case, did you perform an autopsy on Nathan Rawls on November 6th, 2013 at approximately $10:20 \ A.M.$?

A Correct.

Q And when you do an autopsy, can you explain to the members of the jury just kind of generally what happens? Do you go into a room and is the body there in front of you?

A Correct. Then I do an inspection of the external body from the top of the head to the bottom of the feet, make some incisions in the body, remove the internal organs, examine those, and then examine the internal body surfaces.

Q Okay. In regard to this case, you noticed that there were three gunshot wounds, is that correct?

1	A That is correct.
2	Q And when you do your external examination, do you
3	just sort of look over the body, or is there, you know, just a
4	general inspection?
5	A Well, I take any kind of abnormalities, I take
6	some, you know, detailed observations of those.
7	Q Besides doing the external evaluation in this case,
8	you also do an internal evaluation, is that correct?
9	A Correct.
10	Q And you talked about how you remove different
11	organs, and you sort of weigh them and do things like that, is
12	that correct?
13	A And then examine them, yes.
14	Q And then do you also just as an overview do sort of
15	radiological exams as well, or x-rays in this case?
16	A $$ Prior to the start of the autopsy, yes.
17	Q Okay. In regard to this victim, you did an external
18	examination. Was there any significant findings that you
19	made?
20	A Yeah, he had a number of gunshot wounds.

23	don't know though whether that was the order in which the

Q Okay. In regard to the first gunshot wound, can we talk about that?

A Yes.

Q Besides obviously seeing the gunshot wound on the outside, can you tell us anything about the internal examination that you did?

A Well, that particular gunshot wound that entered in the right upper back, it did a substantial amount of damage internally, very lethal damage, including to the aorta, and there was a large amount of blood in his chest.

Q Can you tell us -- you said that it entered into the right upper back area. Can you tell us the way the bullet traveled?

A It entered in the right upper back, crossed through the central chest and came out the left upper chest, and it hit both lungs, the heart, and the aorta.

Q Okay. Can you tell whether it went front to back, or right to left?

 ${\tt A}$ Well, it would be a front to back, and then right to left.

Q Okay. You also in your report talked about -- and you don't use this word, this is my word, "stippling." Can you explain to the members of the jury what stippling is?

A Well, stippling -- a bullet is powered by powdered

nitroglycerin, actually. Not gunpowder, but nitroglycerin, and these are in granules like salt. And any kind of ignition of those granules is never perfect. There's always unburnt granules.

And so, when the explosion happens and the bullet takes off down the barrel and passes outside of the barrel, right behind it is a lot of gasses and smoke, but there's also unburned granules and these do have a velocity to them.

They're little — they're small little granules. And with a handgun, they actually have a pretty decent velocity, up to about 24 inches outside of the barrel, and after that, they fall off.

If a person sustains a gunshot wound within that 24 inches, those granules will strike the skin, and they may embed themselves in the skin, or they just may injure the skin and bounce off, and it causes these little punctate injuries, and it's called stippling.

Q And in regard to this case, did you see any stippling?

A No.

Q So, what did that indicate to you?

A Well, it could mean either the gun was more than 24 inches away, or it could mean that the decedent was wearing some significantly heavy clothing at the time of the gunshot wounds.

So, on November 5th, 2013, you're at the 1.4 hospital. Do they discharge you from the hospital? 15 Α Yes. 16 Do they give you any paperwork or tell you about 17 anything about aftercare? 18 The only thing they gave me, they gave me a 19 prescription for Percocet, I believe like 2.5. They told me 20 to stay off it as much as possible because it could be a 21 deadly injury that would travel, however, they didn't think to remove it at that time. 23 Okay. From when you leave on November 5th, 2013 24 until eventually the bullet was removed, can you explain to 25

the members of the jury what you went through in regard to
your injury from that day until they removed it?

A Pretty much I was walking around everywhere with a

bullet in my foot. I didn't have any transportation. They told me to be as careful as I could, but you can't really be careful with a bullet in your foot because you have to walk. And any type of nick or bump to it they said could be harmful, but I have to wait for a specific doctor in order to try to get it removed out. It was just a hassle, pretty much.

Q Did it hurt? Did it get infected?

A It was very painful. I did have to go in to get additional antibiotics and packing, because it did get infected for staying in there too long.

Q Okay. Eventually, nine days later, did you go back to Sunrise Hospital?

A Correct. I went back to Sunrise, and they had put me in as an emergency so that I can get the bullet removed as soon as possible, where I underwent a surgery to get it surgically removed.

Q So, you went through surgery and the bullet was removed?
