MEMORANDUM

I, RYAN J. MACDONALD, am a duly licensed attorney in the State of Nevada and am employed by the Clark County District Attorney's Office. The State is requesting a 30 day extension of time in which to file Respondent's Answering Brief, pursuant to NRAP 31(b)(3).

This case is a direct appeal of Matthew Washington's convictions. On January 9, 2015, this Court granted Washington's Motion for Extension of Time. On February 19, 2015, Washington filed a second Motion for Extension of Time, which this Court granted in part on February 27, 2015. On April 21, 2015, Washington filed a third Motion to Extend Time to File Opening Brief, which this Court granted on April 24, 2015. On June 2, 2015, Washington filed his Opening Brief.
