14                           **MOTION FOR EXTENSION OF TIME TO FILE THE DOCKETING**  
15   **STATEMENT**

16           NRAP 14(b) states,

17  
18           **(b) Time for Filing; Form of Docketing Statement.** Within 20 days after  
19 docketing of the appeal under Rule 12, the appellant shall file a docketing  
20 statement with the clerk of the Supreme Court, on a form provided by the  
21 clerk. Legible photostatic copies of the original form provided by the clerk will  
22 be accepted by the clerk for filing in lieu of the original form. The appellant  
23 may file a docketing statement that is not on the form provided by the clerk so  
24 long as it contains every question included in the clerk's form. An original and  
25 2 copies shall be filed, together with proof of service of a copy of the  
26 completed statement on all parties and, if the appeal is assigned to the Supreme  
27 Court settlement program under Rule 16, on the settlement judge.


26           **(d) Extensions of Time.** A motion for an extension of time within which to  
27 file the docketing statement will be granted for good cause. Counsel's caseload  
28 generally will not provide grounds for an extension

1 The Cross-Appellant's docketing statement is due on August 18, 2014. Cross-  
2 Appellant hereby moves for a 7-day extension of time for filing the docketing statement,  
3 thereby making it due on August 25, 2014. The docketing statement in this case is  
4 unusually complex as it relates to issues before the Court on appeal. This case was highly  
5 contentions and involved numerous motions and multiple judgments from those motions  
6 that caused the district court to enter the Order that is being appealed. While the attorneys  
7 for the Cross-Appellant are diligently working on the docketing statement, due to the  
8 complexity of this case, it is extremely difficult to meet the present deadline of August 18,  
9 2014.

10 Therefore, Cross-Appellant requests a 7-day extension until August 25, 2014 for  
11 filing the docketing statement.
